

From the 2/3/22 release of VAERS data, there are 28,075 adverse event reports from the Covid shot in Indiana, up from 28,051 since the last report 7 days prior.

- 16 year old female got the Pfizer shot on 12/21/21. On 1/19/23 she had an ischemic stroke on the right side of her brain. A blood clot was identified and removed. She was hospitalized for five days. ID [2569360](#)

She had the same symptoms again. She had strep twice in November of 2021. She got her 4<sup>th</sup> dose on 1/20/23. On 1/22/23 she began to experience fatigue, blisters under her tongue, pain in upper and lower teeth on right side, swelling of her jaw, ear pain, headache. - 57 year old female got her 4<sup>th</sup> dose of Moderna on 12/17/22. On 1/24/23 she began having symptoms over a period of a few days including tickle in throat and coughing up dark phlegm. She was given an antibiotic shot and a steroid shot and told she had bronchitis. ID [2570710](#)
- 89 year old male got his 4<sup>th</sup> dose of Pfizer on 12/13/22. On 12/17/22 he developed blood clots in both lungs. ID [2571732](#)
- 3 year old female got the 2<sup>nd</sup> dose of Pfizer on 7/31/22. On 1/13/23 she developed a rash on her right arm which started to spread. All labs came back normal and parents were told she had a viral rash. It cleared up a couple days later. ID [2572076](#)
- 80 year old female got her 4<sup>th</sup> dose of Pfizer on 12/29/22. On 1/7/23 she began to experience weakness, chest pain and left arm pain when coughing. On 1/10/23 she tested negative for influenza A & B and was told she had bronchitis and was prescribed a z-pak. On 1/17/23 she still had a cough and weakness and went to her PCP. A chest xray on 1/20/23 showed cardiomegaly (enlarged heart) and a CBC showed pancytopenia (significant reduction in all blood cells) a known chronic condition for this patient. On 1/27/23 she went to the ER with chest pain, weakness, and right arm pain. An echocardiogram showed moderate pericardial effusion. She was started on prednisone and colchicine and still hospitalized at the time of this report on 1/31/23. ID [2572095](#)
- 63 year old male got the 2<sup>nd</sup> dose of Pfizer on 4/10/21. On 1/30/23 he sudden left-sided facial numbness and left arm weakness to the point he couldn't lift his arm. At the time of arrival to the ER his BP was 154/89. MRI of the brain showed small acute infarcts (stroke) in the right frontal lobe. ID [2572113](#)
- 37 year old male got the Pfizer shot and a Hep A vaccine on 11/1/22. On 1/10/23 he began experiencing depression and went to see a doctor who provided no treatment and told him to see his PCP. No change at the time of this report on 2/1/23. ID [2573441](#)
- 82 year old male got the 4<sup>th</sup> dose of Moderna on 10/14/22. In December of 2022 his PSA was 102.30. CT scan of the abdomen and pelvis showed multiple liver metastatic lesions. Biopsy of the prostate showed cancer. ID [2574247](#)

- 76 year old female had the 4<sup>th</sup> dose of Pfizer on 12/28/22. She tried to get out of bed in the middle of the night on that same night and fell to the floor. She was taken to the ER and admitted to the hospital for 3 days. Her symptoms disappeared as quickly as they came on. ID [2563520](#)
- 57 year old female got the 2<sup>nd</sup> dose of Pfizer in 3/13/21. Beginning around 5/20/21 she began experiencing cluster headaches and was also diagnosed with peripheral neuropathy. The cluster headaches were quite intense and occurred every evening for about a month. She received a bivalent booster on 5/28/22 and the cluster headaches returned for two weeks on 6/4/22. - 46 year old female got the Moderna shot on 3/18/21. On 4/1/21 she began experiencing cardiac events including sharp chest pains, dizziness, and her heart hurting. - 18 year old male the 4<sup>th</sup> dose of Pfizer and a flu shot on 1/22/23. He began feeling dizzy and lost consciousness about 30 seconds later for 10 seconds. He was feeling better after about 10 minutes. ID [2565180](#)
- 46 year old female had the 3<sup>rd</sup> dose of Pfizer on 1/18/22. On 1/21/22 she had a lymph node enlarge to the size of a plum under her arm. This lasted one week and was causing pain all the way to her breast. More lymph nodes enlarged on her breast. She began having trouble with her period. In March of 2022 she began having pain around her eye. She went to an eye doctor who found nothing wrong. She saw an ear, nose, and throat doctor who found nothing wrong. She began having sensations that burning water was being poured all over her head. An MRI and blood tests found nothing abnormal. She saw a neurologist, a rheumatologist, and two family doctors. She sometimes cannot move her body, she has blurry vision, has the feeling of something crawling through her legs, her hands were turning blue, purple, and white, her breasts were painful, she has stomach pain and nausea, and a rash on her legs.. She had mammograms in December of 2022 and 1/5/23. They found thick tissue, abnormality. The burning sensations are now gone at the time of this report on 1/23/23. ID [2565755](#)
- 74 year old female got the Pfizer shot, as well as flu, hep a, hep b, tdap, typhoid, and yellow fever vaccines on 12/2/22. She got hives on her neck, arms, torso, and the area above her knees one week later. She was given six days worth of prednisone and a topical cream for itching. ID [2566679](#)
- 79 year old male got his second dose of Moderna on 2/25/21. He tested positive for covid on 1/8/23 and **DIED** on 1/19/23. ID [2566936](#)
- 74 year old male got the 5<sup>th</sup> dose of Pfizer on 10/4/22. For about a month his lungs felt “heavy.” By 10/14/22 he was having pain. He went to the ER unable to draw a full breath and exhausted. He was hospitalized for two days and diagnosed with pulmonary embolism. ID [2567328](#)
- 29 year old male got the 4<sup>th</sup> dose of Pfizer in October of 2022. He had been having headaches since June (5 months after his 3<sup>rd</sup> dose) and their intensity increased after this dose. ID [2567717](#)
- 68 year old female got her 4<sup>th</sup> dose of Pfizer on 11/9/22. While her husband was driving her home she felt a warm rush go through her body and she lost consciousness briefly. ID [2567762](#)
- 34 year old female got the 2<sup>nd</sup> dose of Moderna on 8/1/21. Her migraine medication stopped working on 11/1/21. No other medications, injections, or infusions have worked for her complex migraines since. - 37 year old male received the 3<sup>rd</sup> dose of Pfizer on 3/1/22. After having a glucose test result of 99 in February of 2022, he had a result of 700 in June of 2022. - 77 year old female got the 4<sup>th</sup> dose of Pfizer 7/27/22. On 8/30/22 the white of her left eye became red. Her doctor told her to take lumify. It reduced the redness for half a day, but then it would return. She went in to see the doctor and he determined it was not infection but inflammation and put her on a steroid which she took for three weeks. From the 1/20/22 release of VAERS data, there are 27,873 adverse event reports from the Covid shot in Indiana, up from 27,857 since the last report 7 days prior.

- 31 year old male got the Johnson & Johnson shot on 1/10/22. On 1/8/23 he experienced what he thought was a heart attack. His chest was hurting, his heart rates spiked to 160 while at rest, and his hands and feet went numb. In the ER he had bloodwork, an EKG, and an xray. The hospital was unable to determine what caused his symptoms. His PCP has referred him to a cardiologist who is unable to see him until February. In the meantime he continues to experience spikes in heartrate from things as simple as walking from one room to another. ID [2559481](#)
- 50 year old female got the 3<sup>rd</sup> dose of Moderna on 4/8/22. Beginning the next day her lymph node in her armpit on the side she got the shot became sore. It continues to be sore at the time of this report on 1/13/23.
- 80 year old male got his 4<sup>th</sup> dose of Moderna on 8/29/22. On 10/22/22 he had an ischemic stroke on his left side which affected the right side of his face and has left him with slurred speech. ID [2560045](#)
- 50 year old female had her 4<sup>th</sup> dose of Pfizer on 1/12/23. The next day she began experiencing fever, cough, chest and nasal congestion, tachycardia, night sweats, neuropathy, tremors and incessant shaking at night, headache, and body aches. ID [2560230](#)
- 57 year old female got the 2<sup>nd</sup> dose of Moderna on 2/2/21. She slept for 35 hours after her shot and felt like she was having a reaction to it. On 5/1/21 she **DIED** of presumed heart complications of an aortic dissection or stroke. ID [2560334](#)

- 44 year old male got the Pfizer shot on 12/15/22. On 1/6/23 he awoke with right-sided weakness from foot through arm, developed aphasia (loss of the ability to articulate ideas or comprehend spoken or written language, resulting from damage to the brain from injury or disease.) CT scan showed high left carotid dissection (tear in carotid artery) and complete left M1 branch thrombus occlusion (blood clot.) Was in hospital for two days and placed on light duty for 4 ½ weeks until follow up with neurology. ID [2561135](#)
- 65 year old female got 5<sup>th</sup> dose of Pfizer on 10/17/22. She began having skin symptoms on 11/2/22. Her skin is red and very itchy, and she gets welts from the smallest scratch or cut. ID [2561390](#)
- 56 year old female got the 2<sup>nd</sup> dose of Pfizer on 2/5/21. On an unspecified date after this she was diagnosed with non-Hodgkin's lymphoma. ID [2561922](#)
- 51 year old male got 2<sup>nd</sup> dose of Pfizer on 5/19/21. He has been sick ever since. He has been tested for many diseases by many different types of physicians: neurologists, rheumatologist, primary care physician who has referred him out seven times. - 71 year old male got the first dose Moderna on 1/27/21 and on an unknown date got the second dose. On 1/6/23 he began experiencing ventricular extrasystoles (arrhythmia.) ID [2552386](#)
- 15 year old female got Pfizer shot on 6/7/21. On 2/10/22 she was diagnosed with hypersensitivity vasculitis, an acute condition that causes inflammation of small blood vessels. She had red spots on her legs, arms, and back with pain, swelling, and bumps. At times she could not walk due to the pain. She had several flare ups over the course of 2022 during which she missed school and work. - 67 year old male got the 3<sup>rd</sup> dose of Pfizer on 1/1/22. The same month he began experiencing headaches and medically significantly decreased blood platelet counts. - 71 year old female got the Moderna shot on 11/23/22. Her arm was in extreme pain to the point she could not move it. After a week of this her doctor put her on 800mg of ibuprofen. - 71 year old female got her 4<sup>th</sup> dose of Pfizer on 4/27/22. On 4/28 she had fatigue that lasted for seven days. On 5/4/22 she began to experience an increased heart rate. - 68 year old female got her 3<sup>rd</sup> dose of Pfizer on 1/14/21. By 5/1/22 she had widespread/diverse severe eczema covering much of her body. She has numerous lesions and extreme itching. Topical steroids brought no relief and oral steroids brought little relief. They are considering Dupixent and other treatments. The damage she has experienced is likely permanent and lifelong. This went on until continued until 4/7/22 when she had a hemorrhagic stroke. She remained in the hospital rehab until 5/20/22. Her headaches continued until July or August. - 29 year old female got the Moderna booster 7/2/22 (prior two shots were Pfizer.) On 9/6/22 she began having recurring issues with ovarian cysts that burst and one of her fallopian tubes got infected. ID [2536658](#)
- 60 year old female got the Pfizer shot on 9/19/22. On 12/11/22 she experienced body aches, chills, and her heart felt like it was skipping beats. She had dizziness and nausea that lasted a few hours and recurred a couple days later even stronger and lasted a few hours again. She felt fatigued the entire week. Bloodwork came back normal. - 52 year old female got the Moderna shot on 11/3/22. Onset date of symptoms is listed at 11/1/22 but looking at the rest of the dates in her write up, that is likely an error and should say 12/1/22. She had inflammation of the spinal cord, unspecified cord compression, numbness and tingling of all limbs, primary hypertension, abnormal reflexes, and other symptoms and signs involving the musculoskeletal system, anemia, low B12 vitamin levels. She was hospitalized from 12/11/22-12/17/22 and received 5 days of Prednisone steroid, intramuscular injections of B-12 vitamins, and surgery was recommended to decompress spinal cord inflammation at neck. - 39 year old male got the Moderna shot on 12/23/21. He had sudden cardiac arrest and **DIED** on 1/5/22. ID [2538459](#)

- 49 year old male got the Moderna shot on 2/4/21. On 5/13/21, he began feeling like his heart rate was high. In the ER he was diagnosed with atrial flutter and was prescribed a blood thinner and a med to control heart rate. ID [2528369](#)

- 49 year old male got the Pfizer shot on 10/1/22. On 11/4/22, he had deep pressure, mid chest discomfort radiating to jaw lasting several hours and worse with reclining. He went to ER on 11/5/22. EKG showed no acute injury. First troponin elevated. 11/6/22 heart cath showed normal coronary arteries. 11/7/22 cardiac MRI showed myocarditis. Was placed on colchicine. ID [2529499](#)

From the 12/9/22 release of VAERS data, there are 27,624 adverse event reports from the Covid shot in Indiana, up from 27,494 since the last report 7 days prior.

- 56 year old male got the Moderna shot and a flue shot on 11/4/21. On 11/20/21 his joints became very weak. His elbows, shoulders, hips, and ankles had no energy for days. It was like his arms just wanted to hang because his joints were so weak. He could barely push the pedals to drive his ankles were so weak. This lasted for about a week. As of the time of this report on 12/5/22, he still experiences this from time to time. ID [2522963](#)
- 31 year old male had the Moderna shot 12/2/21. On 8/1/22 a diagnostic ultrasound located a nodule on his left thyroid lobe. On 10/25/22 a biopsy showed he has thyroid cancer. He was told he had a genetic marker that predisposed him to developing thyroid cancer. At the time of this report on 12/5/22, he is scheduled for surgery the following week. - 65 year old female had the Pfizer shot on 11/9/22. On 11/12/22 she was diagnosed with blood clots in her lungs. ID [2525441](#)
- 72 year old male had the Pfizer shot 6/14/21. By the next day he had an aversion to food, diarrhea, episodes of chills and feeling hot, feeling of "insides of his body crawling around", sweating, vomiting, and muscle twitching in his back. He had extensive weight loss, was diagnosed with a massive fungal infection, vitamin deficiency, anemia. He saw the doctor five different times trying to get all this under control, but he is nowhere near normal and his quality of life has been greatly diminished.
